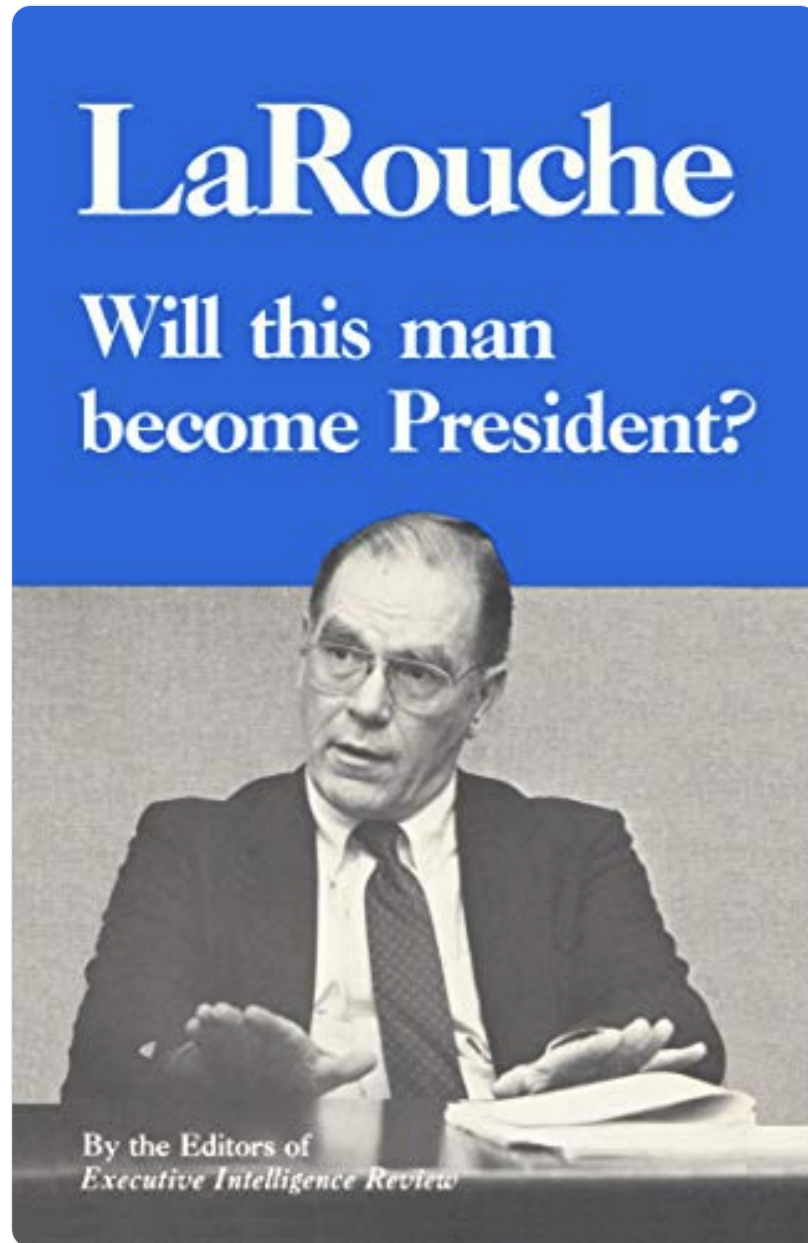

M.T.: Your late husband assumed that the dominant imperialist force operating on the planet today is not the United States, but the Anglo-Dutch liberal system of the British Empire. Do you know what LaRouche based his assumptions on?

H.L.: He studied the history of empires: the Persian Empire, the Roman Empire, the Byzantine Empire, the Venice Empire, the Dutch and British Empire. He coined a very important notion that the empires are like a slime mold. It's a kind of a mushroom that changes its color. It looks depending on what the environment is. But it, in essence, remains a mushroom, a slime mold. And he said the empires are like that.

EMPIRES OVER THE CENTURIES WOULD CHANGE. THEY WOULD LOOK A LITTLE BIT MORE LIKE THAT OR THIS. BUT IN ESSENCE, IT WOULD BE THE SAME PRINCIPLE, NAMELY THAT YOU HAD AN OLIGARCHY, A SMALL ELITE, POWER ELITE.

Sometimes it was nobility. Then it was finance, you know, so that changes, but that that small elite would try to keep the majority of the population as backward as possible and to actually lower their sense of identity because the lower the people would be, the better they could defend their privileges. People think today that there are no more empires, but I think they are unfortunately alive and kicking. And I think the most recent example is the British Empire, which seems to be quite active in politics today.

A '60's Socialist Takes a Hard Right

I met Lyndon LaRouche Jr. when we were both members of the Socialist Workers Party (SWP), the main Trotskyist group in the U.S. and about as far left as you could be in those days. I was an SWP member from 1957 until 1964, and so was LaRouche. At that time he went by his party name, Lyn Marcus. He told me that he had visited India as a soldier at the end of World War II and the revolutionary ferment he had witnessed there convinced him to become a radical. After a short period around the Communist Party, he joined the Trotskyists in Boston. When I first knew him, LaRouche was inactive in the SWP and was earning a living as an economic consultant in the shoe industry.

In the summer of 1965 I headed a small group of Trotskyists, the American Committee for the Fourth International (ACFI), which had split from the SWP in September 1964. LaRouche and his new wife, Carol, left the SWP and joined our small group. For about six months thereafter I met with LaRouche almost everyday.

The LaRouches lived in a small, cluttered apartment in Manhattan's West Village that was filled with books, documents and a portable typewriter. I saw no signs that he was holding a job. LaRouche churned out lengthy typewritten documents. He had already developed many of the basic ideas that flowered in his days as an independent leftist and that he later adapted to his rightist politics.

LaRouche had a gargantuan ego. Convinced he was a genius, he combined his strong conviction in his own abilities with an arrogance expressed in the cadences of upper-class New England. He assumed that the comment in the Communist Manifesto that "a small section of the ruling class cuts itself adrift, and joins the revolutionary class..." was written specifically for him. And he believed that the working class was lucky to obtain his services.

LaRouche possessed a marvelous ability to place any world happening in a larger context, which seemed to give the event additional meaning, but his thinking was schematic, lacking factual detail and depth. It was contradictory. His explanations were a bit too pet, and his mind worked so quickly that I always suspected his bravado covered over superficiality. He had an answer for everything. Sessions with him reminded me of a parlor game: present a problem, no matter how petty, and without so much as blinking his eye, LaRouche would dream up the solution.

He was one of us for only six months. He then moved to another Trotskyist group, the Spartacist League. Unable to win this group over to "LaRouchism," the LaRouches left after a few months. Later the SWP received a letter from him pompously announcing that all factions and sections of the Trotskyist Fourth International were dead, and that he and Carol were going to build the Fifth International.

Though often dismissed as a bizarre political cult, the LaRouche organization and its various front groups are a fascist movement whose pronouncements echo elements of Nazi ideology.[1] Beginning in the 1970s, the LaRouchites combined populist antielitism with attacks on leftists, environmentalists, feminists, gay men and lesbians, and organized labor. They advocated a dictatorship in which a "humanist" elite would rule on behalf of industrial capitalists. They developed an idiosyncratic, coded variation on the Illuminati Freemason and Jewish banker conspiracy theories. Their views, though exotic, were internally consistent and rooted in right-wing populist traditions.

A former Trotskyist, Lyndon H. LaRouche, Jr., founded the National Caucus of Labor Committees (NCLC) in 1968 as an offshoot of the radical student movement. But in the early 1970s, LaRouche engineered a political about-face, using cult pressure tactics to consolidate his grip over the NCLC and initiating a campaign of physical attacks on Communists and Black nationalists, which cut his followers off from the Left. The result was a fascist organization with some unique strengths: a dedicated, full-time cadre of several hundred members, a high proportion of intellectuals with advanced training, familiarity with leftist theory and organizing, and inside information about radical organizations and leaders.


During the 1970s and 1980s, the LaRouchites built an international network for spying and propaganda, with links to the upper levels of government, business, and organized crime. The LaRouchites traded information with intelligence agencies in the United States, South Africa, East Germany, and elsewhere. Their dirty tricks record included harassment campaigns against the United Auto Workers and the United Steelworkers of America in the 1970s. In 1980, they branded George Bush an agent of the Trilateral Commission to help Ronald Reagan win the Republican presidential nomination, and in 1984, they helped Jesse Helms retain his U.S. Senate seat by gay-baiting his opponent. During the 1980s, the LaRouchites raised an estimated \$200 million through legal and illegal fund-raising and fielded thousands of candidates for political office in every region of the country. Seeking the George Wallace vote, the LaRouche candidates usually ran in Democratic primaries.[2]

The LaRouchites generally operated under front groups such as Food for Peace and the Schiller Institute, and

While initially almost all U.S. think-tanks were negative concerning China's Belt and Road Initiative (BRI), or simply refused even to take note of it, there has recently been a shift. There are several roadblocks to be overcome for this to happen.

The infrastructure requirements of the United States are enormous, due to decades-long non-investment by the previous administrations. Except for those who have actually been to China, most Americans have no idea how far behind China is U.S. infrastructural develop-

ALEXANDRIA, Va. — A Texas man pleaded guilty today to conspiracy to distribute up to 15 kilograms of cocaine and conspiracy to commit money laundering.

According to court documents, between June 2014 and November 2016, Naleth Vongsengchanh, 50, of Houston, engaged in a conspiracy to traffic quantities of cocaine to Virginia for redistribution and to launder the proceeds. In the beginning of the scheme, Vongsengchanh resided in the Virginia region and sold cocaine locally before relocating to Houston.

Beginning in January 2015, Vongsengchanh began providing other individuals with kilogram quantities of cocaine to be transported from Texas to Virginia by car. Furthermore, Vongsengchanh and his spouse at the time, Oksana Vovk, utilized numerous bank accounts to launder the drug proceeds stemming from the cocaine trafficking. One of the utilized accounts was for an illegitimate business known as Stylish Traveler LLC through which Vongsengchanh and Vovk laundered over \$78,000. In addition to the laundering of the proceeds, Vongsengchanh received payment for cocaine via other individuals transporting bulk cash currency for the former couple from the Virginia region to Texas.

Vongsengchanh is a career offender with a lengthy criminal history that includes felony convictions for murder in the second degree, voluntary manslaughter, assault with a dangerous weapon, aggravated assault with a deadly weapon, and two convictions for manufacturing, sale, and possession of a controlled substance.

Vongsengchanh pleaded guilty to conspiracy to distribute five kilograms or more of cocaine and conspiracy to commit money laundering, and faces a mandatory minimum of 10 years in prison, and a maximum term of life in prison when sentenced on April 17. Actual sentences for federal crimes are typically less than the maximum penalties. A federal district court judge will determine the sentence after taking into account the U.S. Sentencing Guidelines and other statutory factors.

INTRODUCTION

Defend Mankind from the Satanic Climate-Change Swindle

Exactly 70 years after the end of the Nazi dictatorship, preparations are underway—largely unnoticed or misinterpreted by unsuspecting contemporaries—for the establishment of a fascist world government which would exceed Hitler's most audacious dreams. In place of the discredited doctrine of eugenics, which provided the pretense then for the elimination of so-called "inferior races," today it is the swindle of alleged anthropogenic climate change which supplies the argumentation to establish a global eco-dictatorship whose results, and whose declared intention is to eliminate six billion human beings—if it is not stopped.

On November 30-December 11 of this year, the COP21/CMP11 Climate Summit will take place in Paris, also called "Paris 2015." There a binding international convention is supposed to be concluded, obligating every nation in the world to agree to so-called climate goals in order to hold global warming to less than two degrees Celsius. This largest diplomatic conference ever to have taken place in Paris, a mammoth spectacle with about 40,000 participants, is supposed to represent the crowning conclusion to an unprecedented series of dozens of international conferences all during this year on the subject of anthropogenic climate change, aiming to get the agreement of political leaders, industry representatives, union leaders, religious representatives, and social groups of all kinds to this oncoming social contract.

Although this theory, spread with an unprecedented expenditure of propaganda, has by now been swallowed by many credulous people, it is in no way "established science," but rather very "old wine in new wine-skins"; namely, the attempt to establish a world government through which to eliminate national sovereignty and thereby the possibility of individuals to participate in government through a representative system. In its place is intended to be a kind of modern feudal

oligarchy, in which the club of billionaires and millionaires live in gross luxury while the mass of the population is to be left in backwardness with sharply reduced living standards, lower life expectancies, and reduced cognitive capabilities.

The means to this end is the scare campaign around man-made climate change, which is supposed to induce people voluntarily to do without virtually all the achievements of material and social progress through industrialization. The goal of such an eco-dictatorship is the "great transformation of the world economy" to the exclusive use of so-called renewable energy sources, and thus the decarbonization of the economy, in which both nuclear energy and fossil fuels disappear as rapidly as possible.

The proof offered for anthropogenic climate change consists of pre-fixed computer models, in which the desired result is determined in advance, and segments of historical climate data are selected in such a manner that they appear to demonstrate the effect of so-called greenhouse gases caused by mankind's industrial production and agriculture. 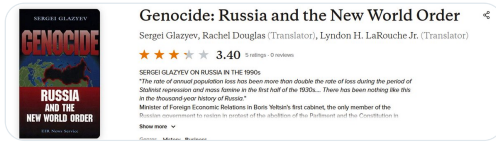
