

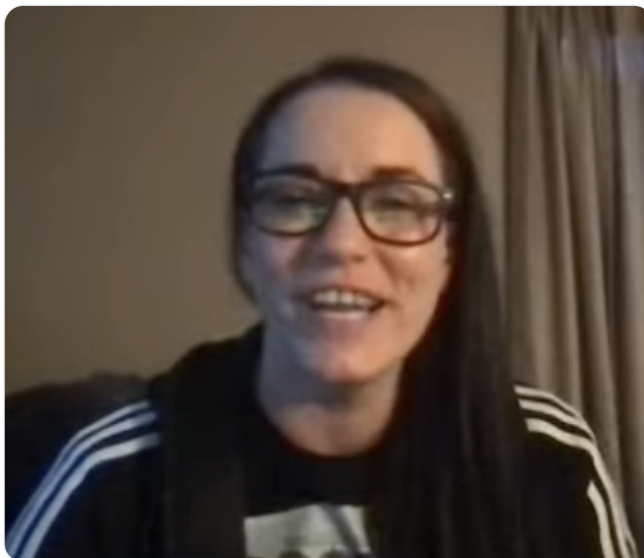

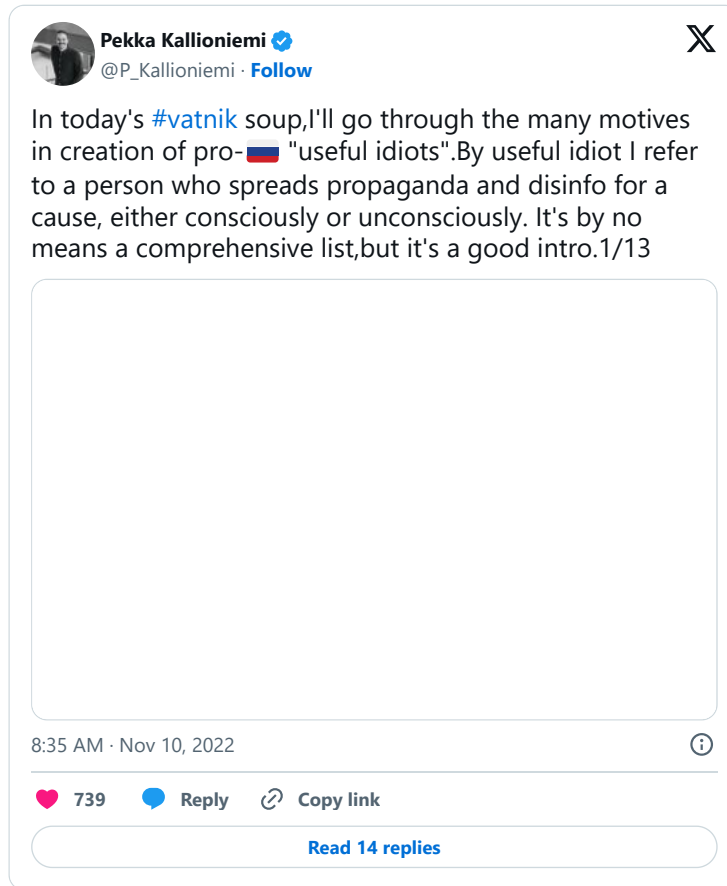

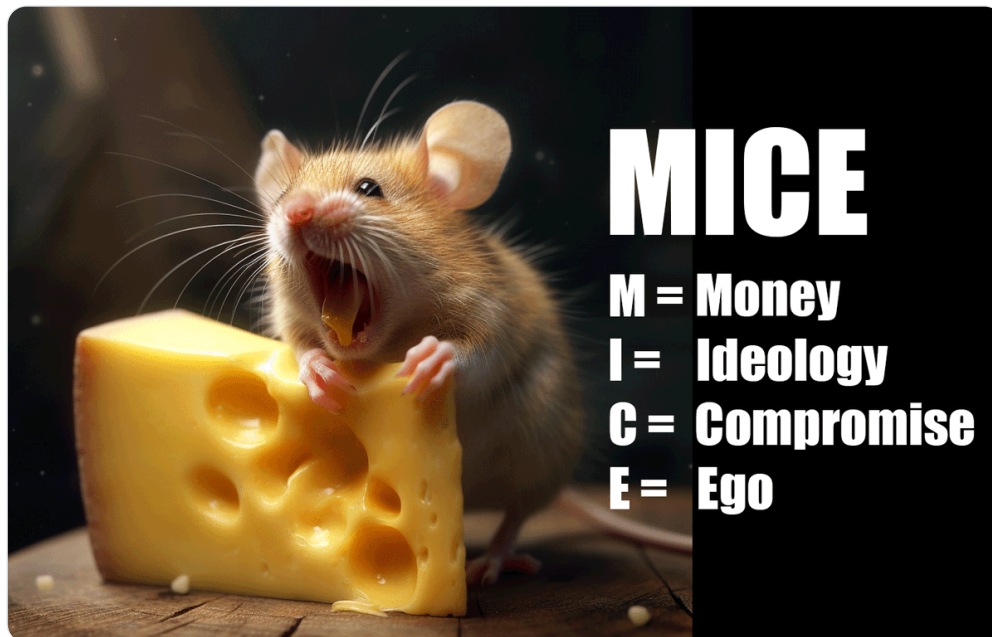
As we've established before, Russian active measures often look for "useful idiots", or people who are willing to spread the Kremlin propaganda without them fully comprehending their goals:

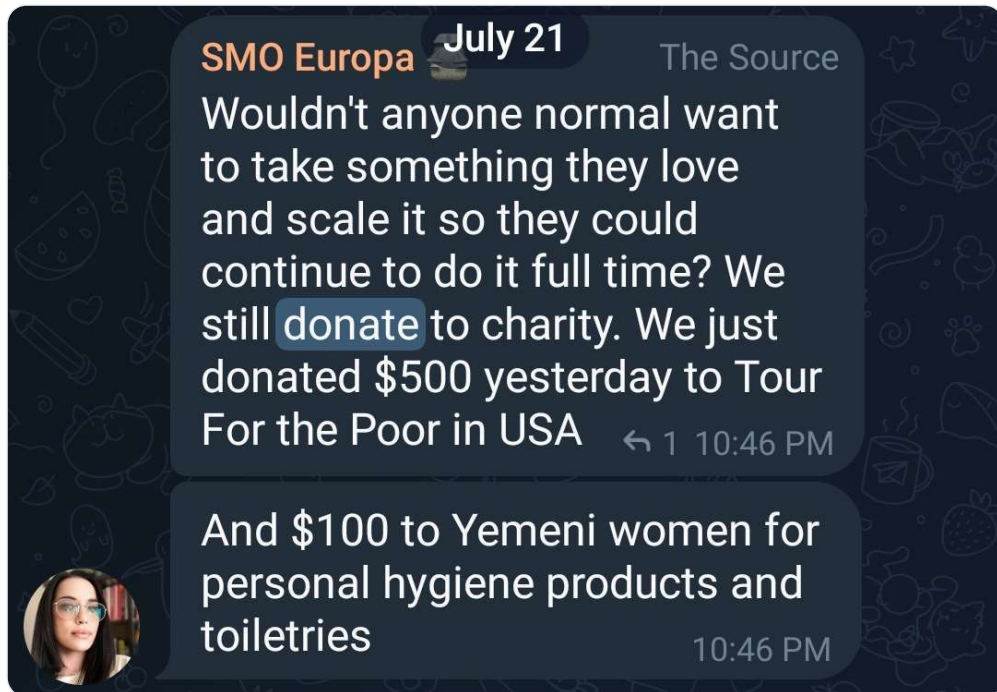

According to court documents, she has a "long-term problem with drugs, alcohol or other substances". She sold her child's toys and was so addicted to being on her phone, that she neglected her child. The house was a mess and there were times she didn't feed them.

Substance Abuse - Sarah Marie Bilis has a long-term problem with drugs, alcohol or other substances that gets in the way of his/her ability to parent.

Sarah uses her phone ALL the time. As a baby [REDACTED] would stand at Sarah's knee screaming, "Mama. Mama," slapping her legs repeatedly until Sarah would look up. When [REDACTED] was 4 she yelled at her mother, "All you care about is your phone."

Due to [REDACTED] multiple deployments Sarah did become the primary parent for [REDACTED] which was a great concern to me. There was never suitable food in the home for a toddler or young child and [REDACTED] resorted to "frozen food stealing" (her parents said) and eating it under her crib. [REDACTED] slept in a broken crib until she was almost 5 when Sarah went on deployment and [REDACTED] bought her a loft bed. [REDACTED] bedding seemed to be rarely if ever washed. On one visit I found 32 socks in it.

She has a massive drinking problem, and she skipped deployments due to this. Once her ex-husband found her passed out on the floor while she was supposed to watch over their kid. She was sent home from deployment for being drunk. She often drank in the presence of her child.

asked to leave there as well. She has always had an issue with her drinking. In the days before departing for her deployment, she was so intoxicated that she claimed that she was sick and couldn't go on the deployment. Pretty much doing whatever she could to get out of the deployment. She even attempted to drive after drinking and I had to take her keys away. During the deployment she had multiple alcohol related incidences. One of which I was called by one of the Chiefs she used to work for and he said she had been making suicidal comments. After this incident I was told by Sarah that she was put on a "No Drinking Order" by the people she works for. The drinking did not stop! I could tell that Sarah was drunk during every conversation.

On June 21st 2021 I came home from work for lunch at 1215pm and found Sarah passed out on the floor. It was scary, I could not let [REDACTED] be a witness to this ongoing behavior anymore, so I called [REDACTED] to come get [REDACTED] and take her to [REDACTED] for the time being. I couldn't allow [REDACTED] to continue to be traumatized any longer (even

When I learned that Sarah was being sent home from deployment, I had no idea why. On June 15th 2021 she came home and told me she sent home for alcohol abuse and was under investigation for Fraternalism and having an Unauthorized absence.

Within days of being home Sarah again began drinking. She had been binge drinking all weekend. I witnessed her drink 2 cases of Seltzers, 2 bottles of Rum and a handle of Titos Vodka.

12. Sarah self medicates with alcohol and as she once said to me, "Once I start I cannot stop." Completely true. [REDACTED] presence was never a deterrent.

According to her ex, she wanted to waive her rights as a parent since she can't afford child support. She was also constantly cheating on him, as testified by her kid. After he filed for divorce, she invited her brother and her mom to live with them.

Since Sarah's return home from her treatment on August 26th, she has already begun drinking again. Since she's drinking she is considered a Treatment Failure in regards to the Navy. Sarah has also expressed to me multiple times that since she can't afford child support, she wants to waive her rights as a parent.

██████████ on Sept. 13. In regards to the divorce ██████████ said, "My parents fight too much." "Mom kissed another man in front of me when Dad was gone." "I think it's not right to have favorites of parents but I like my Dad best."

care for ██████████ while under influence. Also while very has been in Sarah's sole care, ██████████ was not required to shower and forced to match Sarah's diet or simply not eat at all some nights. Sarah was just sent home early from deployment 15 Jun 2021 due to getting in military trouble that included multiple alcoholism incidents. Upon her return home that Thursday and the few days that followed Sarah was constantly drunk and acting inappropriate in ██████████ presence. On the night of the 21st I confronted Sarah about her drinking and inappropriate actions with other men and suggested divorce. She threatened, then attempted to commit suicide by grabbing a knife in the kitchen and putting it to her wrists. At this moment I stopped her and contacted the police. All this happened with ██████████ in the next room. She was escorted by ambulance to ██████████ ██████████ and referred and sent to the Rehabilitation center in ██████████. A military protective order was placed against Sarah on 22 Jul 2021 and sent to the center on 23 Jul 2021. She immediately violated the MPO by contacting me through text. After warning she has since had no contact and is set to stay in the rehab center until around the 9TH of August.

After I returned home from this deployment, Sarah was having an affair with a Sailor who was stationed in ██████████. During one Sunday football game with guests over, Sarah was intoxicated and got mad because the team she was rooting for was losing so she dumped a beer on my head. Later in the evening, the Navy Police came to our home and made her leave and stay in a "cool down room" because she was intoxicated and I was sober.

During my Second deployment, I was deployed to ██████████ ██████████ which at the time, both of those places have no cell phone service or readily available internet. During this deployment I worked 6PM to 6AM 7 days a week and most of our communication was via Email. during this deployment, I learned about an inappropriate friendship she was having with one of her coworkers, (a married male Sailor) and herself.

In the past she had been asked to leave from Bars for being too drunk, she has urinated on the floor in our hallway when we lived in base housing and had no

At some point, Sarah invited her mother to stay at the residence, without discussing it with me, and without my agreeing to this. Sarah hasn't even let me know how long she expected her mother to stay in my home, or what she was going to do in the home while Sarah would be at work. She can't say her mother is here to help her, because neither Sarah, nor her mother, to date, have even packed up one box.

It is extremely uncomfortable to have both of them in my home, especially because Sarah's behavior since coming out of Rehab for six weeks, was to immediately relapse, get drunk and I found her passed out from alcohol. I also have reason to believe that she is still drinking and a bottle of Vodka was found on the floor board of her car by the Tow company, after the car accident. I don't trust Sarah.

Sara also invited her brother to stay at the residence, again without discussing it with me, and without my agreement. Again, this brother has also never come to visit. I don't know this brother, except for his reputation as someone who has a history of drug abuse and theft.

I felt extremely uncomfortable with her family coming to live in the home with no plan at all, especially when I was notified last minute and had no say in the matter. Since Sarah had lost time due to the accident, I allowed for her to stay in the house until October 2, 2021. Even now, she has been back at work and this extra time will give her extra time for a recovery and extra time to find a place to stay.



I did not have to agree to the extra time for her to move out, but I tried to be reasonable in letting her and her mother stay until the October 2nd extension of time, but now she has forced me to incur attorney's fees so that she can see if she can stay-over her deadline. If the shoe were on the other foot, I don't think she would have even agreed to the first extension of time, if I was the one ordered out of the house! presence in my home is disturbing to me.



Since Sarah's mothers' arrival, they've shared a room, bed and bathroom. I have been sleeping in the guest room. The one time I needed to access the Master bedroom, where I used to sleep, to get a uniform from the closet, I noticed that neither the room, or the bathroom, was kept up or cleaned at all. It was filthy and disgusting.

Neither Sarah nor her mother have bothered to clean up after themselves. This is MY home, and they are treating it like a "flop house". I don't live that way and I find their uncleanliness to be unacceptable. They are Guests in my home, but I feel they are taking advantage of me. It is unacceptable and extremely uncomfortable to have to put up with a virtual stranger in my home. Especially a person who doesn't appear to be helping Sarah at all with her moving, which should be the reason she is here. also a bottle of Tito's Vodka that was inventoried to be in her crashed car by Christian's tow company, (which is listed on the tow records). Based on these facts, I do not believe that she has stopped consuming alcohol at this moment in time. The Navy has spent nearly \$138,000 for her 2 months of alcohol and mental health treatment and it seems like it has gotten her nowhere. I cannot continue to witness the behaviors that Sarah is engaging in. Sarah must comply with the agreement to vacate the residence by October 2, 2021.



And about that doxxing: Bills has no trouble spreading other people's personal information and calling for her fans to brigade against them.



She considers TUA and WSJ exposing her lies a "doxx" and constantly lies about the extent of these revelations.

A Make-Believe Past and Present Masks a Strange yet Mundane Reality

A March 2011 marriage license shows that Bils was born in Voorhees, New Jersey, a world away from the Soviet Union. In a phone conversation, Bils's mother denied any knowledge of her daughter's online activity and was unaware of her recent name change. Her parents also refuted they were from Russia, or that Bils had any national connection to the former Soviet Union, the Russian Federation, Ukraine, or the so-called Luhansk or Donetsk People's Republics.

You may ask, "why all these gossip-y details? Why do they even matter?" Well, these are the type of people Russian intelligence targets. Problematic figures who are looking for a some kind of external factor to solve all of their problems, usually related to money.





Now, we know that Bilis has around 63 000 USD in loans and she's willing to do anything to keep up with her lifestyle - even sell her child's toys and try to steal Vicodin. I'm sure even Dmitry Polyanskiy (@Dpol_un) agrees that Bilis would be a perfect asset for the Kremlin.

During her 10-day trip to [REDACTED] to visit my family, she introduced [REDACTED] to my brother and his family. Sarah had found medication (Vicodin) and made an attempt to steal it but was caught. I took her side and stuck up for her because I loved her and she was the mother of my child. After this incident, my relationship with my [REDACTED] and his family has never been the same.

I purchased dolls, dollhouses and other toys. Everything seemed to disappear. Last spring [REDACTED] wanted an LOL dollhouse. When we arrived at the house she said, "I don't want to bring this in. Mom told me I am too old for toys. That's why she sold all my things."

DDG is still actively collecting "donations", and all money goes to Sarah's private account. The network was started in the wake of Russia's full-scale invasion of Ukraine, but has since switched their focus to the next trendy thing, the Israel-Palestine conflict.

 "We in the HAMAS movement appreciate the stance of Russian President Vladimir Putin regarding the ongoing Zionist aggression against our people and his rejection of the blockade of the Gaza Strip, the cessation of humanitarian aid deliveries, and the assault on unarmed civilians. We also confirm our support for Russia's tireless efforts aimed at ending the systematic and barbaric Zionist aggression against the Palestinian people in the Gaza Strip," the text states.

Earlier, the head of the Russian state stated that Israel had been subjected to a brutal attack, but the resolution of the conflict is only possible through the establishment of an independent Palestine with its capital in East Jerusalem. He also noted that in the event of a ground operation in Gaza, civilian casualties would be unacceptable.

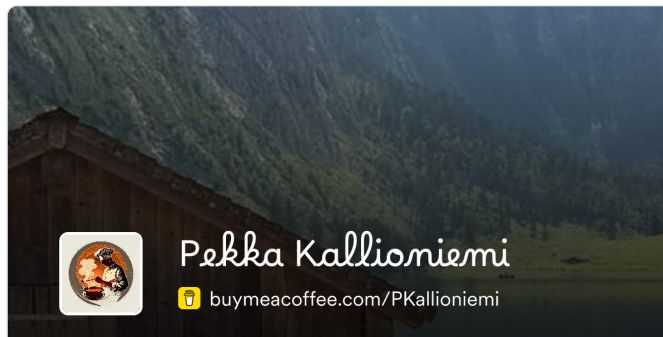
