I was a columnist for *Practical Homeschooling* from its premier issue in Spring 1993 until the fall of 1999. During that time, I wrote about my personal philosophy of home education and the trials and triumphs of homeschooling my ten children from first grade through Master's degrees.

I am best known as a "proponent of accelerated education," although, in fact, I am not any such thing. When I made the decision to homeschool, I did determine that I would have a 12-month school year for my family. However, I based my decision on practical considerations. I thought that if we were to take a three-month summer break, the children would forget much of what they had learned the previous school year. I wanted them to constantly progress, but I did not envision a marked acceleration.

Originally, I had thought that they would graduate "a little early." I was not prepared for them to enter college at 12 and begin graduate work at 15. Three hours a day, five days a week, just didn't seem like it was going to be that big a deal. Yet, they did graduate early. Because of the way their birthdays fell, two were actually 17 when they received their Master's degrees. The other eight received their Master's degrees at 16. What I hadn't factored in was that homeschooled children are able to get so much done in those three hours!

All of the children's educations were entirely through distance learning, and we used the same curriculum for all the children. We used Calvert School in Baltimore for grades 1-8

Ben's family was heavily involved in TV, and he also started working for various channels, first as a cameraman and later as an investigative journalist. Eventually he launched his own news segment called Reality Check, in which he promoted libertarian views and Ron Paul.

# PREACHING THE GOOD NEWS

TV reporter splits time between scoops, spirituality

Not many television news reporters can claim that they are ministers.

Ben Swann, 25, juggles both jobs, reporting news five days a week on Channel 14-KFOX (cable Channel 8) and serving as a Methodist youth minister the other two days.

As a reporter, Swann sees in graphic detail what most people of faith simply acknowledge, that the world is filled with a lot of hurt, fear and depression — many people in distress.

"It's almost a reality check to be in the position I'm in," Swann said. "A lot of times ministers end up almost in a bubble of church life where they only see what people show them."

Swann also sees parallels in handling two jobs as different as night and day.

"You have to be a good communicator whether it's communicating spiritual ideas or sharing ideas

of a story in a simple way," Swann said. "You have to care about people with both. You have to find that human element."

Swann started out at 15 as a youth pastor at a Baptist church in Canutillo, where he grew up. He spent four years there and later traveled across Texas preaching at revivals.

Swann returned to the El Paso area but could not find a full-time pastor position.

Swann had four brothers working in television at the time, and one suggested he try it also. He wound up at Channel 4-KDBC.

In 1998, Swann left Channel 4 to work at KFOX as a cameraman. He left television in 1999 and accepted a job as associate pastor and youth minister at a Presbyterian church in Portland, Ore. Church politics drove him back to El Paso after six months.

## Anchor Ben Swann to Leave WXIX

Ben Swann, anchor for Raycom's Cincinnati FOX Affiliate **WXIX**, has announced he is leaving the station when his contract expires in May.

"After 2 1/2 years at WXIX Fox 19, the time has come for me to explore other opportunities," Swann said in a station announcement [posted to the Cincinnati Enquirer](#).

Swann [also hosts a popular series on facebook](#) titled "Full Disclosure" where he asks questions about controversial subjects he says are ignored by the national media.

"Ben has informed us he would like to take his career in a different direction," FOX19 general manager Bill Lanese told the Enquirer. "We will miss Ben's work ethic and intellect and appreciate him giving us enough notice so we can begin the search for his replacement as soon as possible."

Swann came to WXIX from **KTSM** in El Paso, TX. He also worked at **KFOX** as an anchor, reporter, managing editor and photographer.

Swann told TVSpy he will announce his next move soon.

The report was also posted to Swann's website, Truth in Media, which he created in 2013 and where he posts his CBS 46-funded "Reality Check" segments, many of which echo talking points from websites like RT and InfoWars that are rarely seen in mainstream media.

Recent "Reality Check" topics, which all aired at the 11 p.m. hour in Atlanta, include "Why 'Health Issues' Prove Clinton Campaign 'Untrustworthy' on Many Levels" and "5 Problems with CIA Claim That Russia Hacked DNC/Podesta Emails."

Swann is also "crowdfunding" an episode about how "U.S and partners intentionally created ISIS," through his Facebook page, which has more than 419,000 followers. He's raised over \$12,000 of his \$55,000 goal.

Between 2013 and 2015, Ben also appeared regularly on RT America. In 2014, he hosted the Ben Swann Radio Show on a far-right, antisemitic and conspiratorial network called the Republic Broadcasting Network.

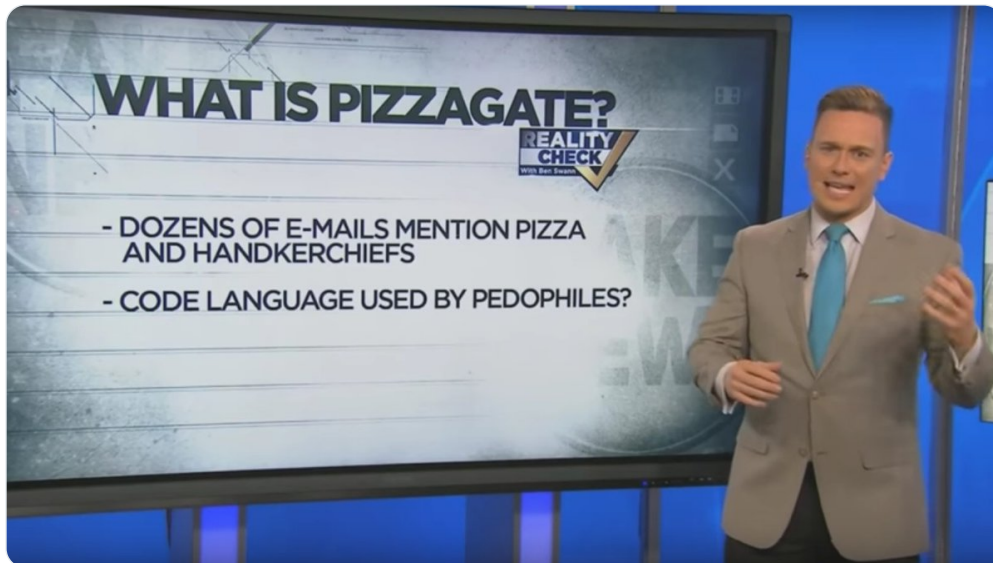

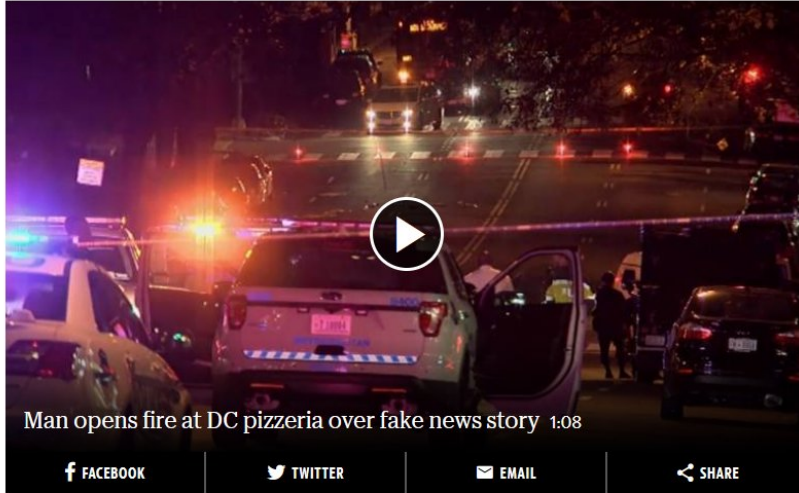

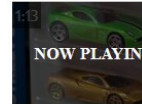

And oh boy, is that rabbit hole deep. Swann has spread conspiracy theories about the Sandy Hook Elementary School shooting (the one that cost Alex Jones dearly), 9/11, and alleged cover-up of connection between the MMR vaccine and autism.

The bill came due Wednesday afternoon, when the New York Times's Maggie Haberman spotlighted Swann's cameo in an ad by the pro-Jeb Bush super PAC Right to Rise. Swann's October "Fact Check" segment on Republican presidential candidate Marco Rubio's voting record in the U.S. Senate was the one RTR used to quickly explain his absences.

Matter-of-factly, Haberman noted that Swann had "examined questions about whether 7 World Trade Center could have collapsed as authorities said it did, and allegations that the gunman in the Sandy Hook Elementary School shootings didn't act alone."

## Ben Swann's long-awaited report on the "CDC whistleblower" goes over like a lead balloon of antivaccine misinformation

He's also spread straight up Kremlin propaganda, including denying chemical weapon attacks conducted by the al-Assad regime and Russians in Syria, and denying the strong evidence that MH17 was shot down with a Russian Buk system by the Russians and pro-Kremlin separatists.

The story even reached a segment on Atlanta's CBS affiliate called "Reality Check with Ben Swann," which has been shared over 61,500 times in the past six days.

"The reports from Aleppo Syria are incredible. The suffering. The humanitarian crisis," said Swann. "But if that's true, why are these people in Aleppo celebrating in the streets?"

This mirrors a narrative within several stories written by Kremlin state media outfit RT in the past several weeks.

"While residents of Aleppo are celebrating the liberation of their city, the mainstream media has been painting the opposite picture with sensational headlines decrying alleged atrocities and a 'meltdown of humanity' they claim is happening there," Kremlin state media outfit RT wrote on its website.

**RT:** *We have seen sweeping headlines from the Western media, like the "international outrage" or "world waiting for answers from Russia". Is it fair to make these accusations before credible evidence has been put forward?*

**Ben Swann:** That is exactly the problem – any credible evidence does not seem to exist at this point. ABC network has a story up that there is an enormous array of facts that Russia supported the rebels accused of downing that airliner. If you just do a simple Google search you will find that Washington Post, New York Times, basically every major news network in the US has reported that there is no question that Russia is involved. We now see the administration is stepping back on some of its comments about the involvement of Russia, even going as far as to say that there is no evidence right now that shows that the missile or training [originated] in Russia.

**RT:** *US officials have said there's no direct evidence linking Russia to the plane crash. Do you think Western media will now continue blaming Moscow for the incident?*

**BS:** They absolutely will. Fox News is now reporting, which is a huge step, that there is no clear evidence that links Russia. Here is what we are going to see happen: the administration gives this kind of soft explanation that they do not have evidence, but with a nudge and a wink they [will] say "but we really know [that Russia was involved]". Media picks upon that, they will begin to report it a little bit, and then in a few weeks we will see that this becomes a non-story in many ways, because it no longer fits the narrative that the administration was hoping for and the media was hoping for, and they will move on to the next story.

After being fired, Swann relaunched Truth in Media and started several other online projects, including a failed social media website called Isegoria and Sovren, a self-described "uncensored, blockchain-based, decentralized news and entertainment platform."

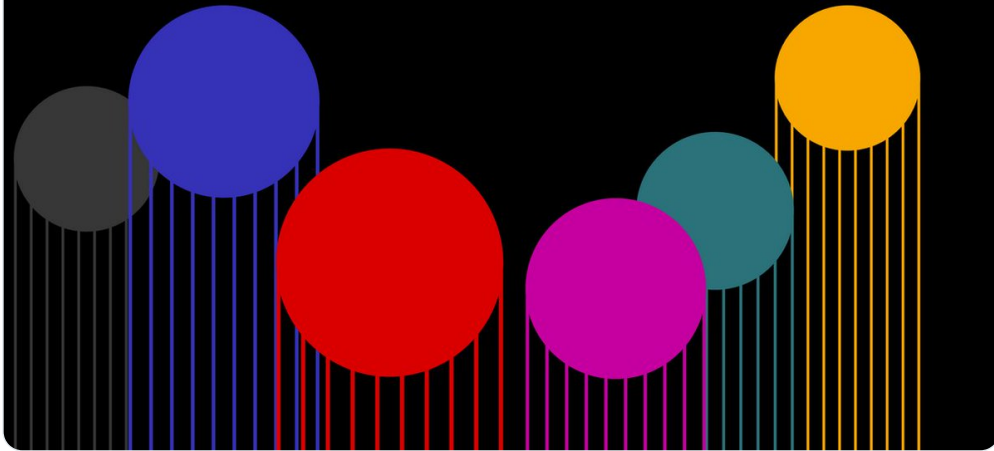

Benny also filed for the Foreign Agents Registration Act, which showed that his company, Rebel Media Productions LLC, was paid 6,8 million USD by the Kremlin. His statement claimed he would "produce propaganda TV content" for the South American, Indian, and Chinese markets.

- We talk about the biggest stories from around the world when it comes to culture battles in the west. From the halting of free speech in Canada to Transgender issues in the United States, there is a culture battle raging that much of the rest of the world finds simply fascinating. A key feature of this show will be to use YouGov or a similar survey company to survey people in 4 or 5 different geographical locations throughout the world to see how they view a particular issue. We would then bring in guests who represent the majority views to discuss these cultural issues.

Swann and Rebel Media are responsible for the production of four English-language shows: 360 View, Cost of Everything, The M.O. and The Whistleblowers. Ben's FARA document stated that the shows are not available in the US, which is a false statement, as they actually are.

8. Describe fully the nature and method of performance of the above indicated agreement or understanding.

Rebel Media Productions LLC will create 4 half hour length television quality shows for distribution in foreign television markets, India, China, Africa and South America. Each contract with TV Novosti, Kart LLC and Stark Industries LLC provides for the creation of 50 episodes of each show (Cost of Everything, 360 View, The M.O. and The Whistleblowers) for distribution by each company. Rebel Media does not broadcast nor disseminate the content, rather we are simply the production house for the content. Again, this content is not for broadcast or dissemination in the United States.



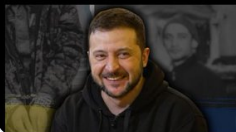

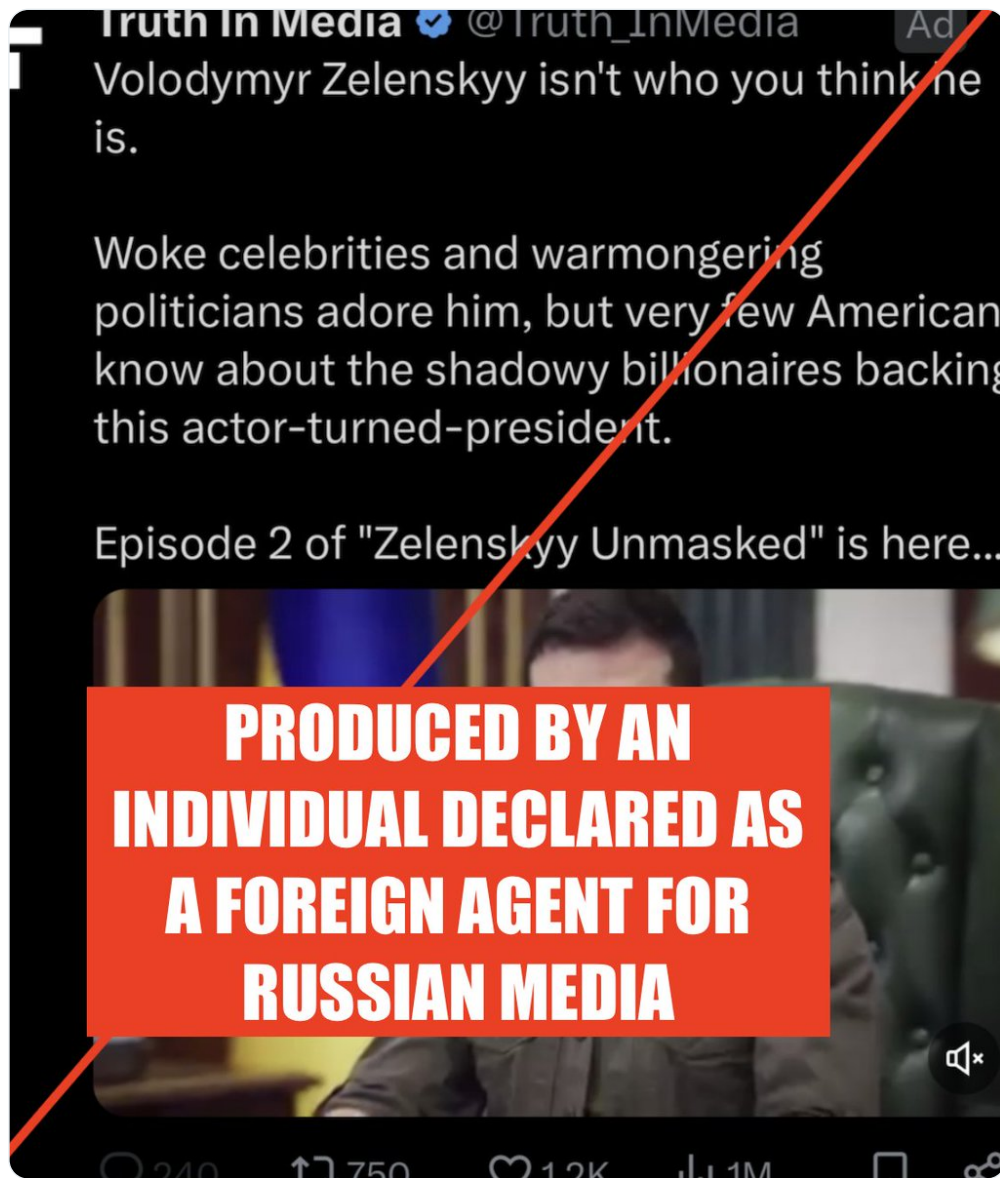
