


Russian intelligence has been extremely active in the Netherlands for a long time. For example in 2018, four GRU agents were caught while trying to hack into OPCW, an organization that monitors the use of chemical weapons. In addition, the International Criminal Court (ICC)... 2/19



...and the MH17 investigation have become targets for the Russian intelligence and propaganda operations. These operations are often complemented with "investigative journalism" media outlets, that often echo the Kremlin's propaganda and disinformation.





One of such media projects is Bonanza Media, founded in early 2019. It was launched by a Dutch vatnik, Max Van der Werff, and Russian Yana Yerlashova. Yerlashova used to work for RT, casting doubt on the official investigation over the MH17 incident.






Even before Bonanza Media, Van der Werff had a long history in supporting the Russia-supported separatists in the Donbas region, and had appeared several times on Russian state media and separatist media in 2015, spreading propaganda about the shoot down of the plane.



Previous Cooperation with Pro-Russian Forces in the Donbas

Before Bonanza Media was created, Max van der Werff had already contacted the Russian-backed separatist authorities in eastern Ukraine trying to help craft a narrative of their lack of culpability in the downing of MH17. In 2016, a leak <u>appeared online</u> from Tatyana Egorova, a staff member of the so-called Donetsk People's Republic's (DNR's) Ministry of Information.



The Egorova Leaks include the entire inbox of the DNR official's Mail.ru account, through which she conducted official "government" business (as is typical through Russia and its separatist "republics"). The leaked emails include a number of correspondences with Max van der Werff in which he volunteers advice on public messaging around the MH17 downing, and requests direct access to materials to help him with his work. Eventually, Van der Werff requests (and receives) access to visit and work in the "DNR", after which he sends a scan of his passport to Egorova.



They also got help from Elena Plotnikova, a Ukrainian pro-Kremlin propagandist and alleged Yanukovych ally. She's a member of an organization called "Global Rights for Peaceful People" whose main mission is to defend the Russia-supported separatists in Eastern Ukraine.




Bonanza's propaganda focuses almost solely on MH17 by providing narratives that are strongly against the official investigation which concluded that two Russians (including Igor Girkin) and one Ukrainian separatist were guilty of shooting down the plane and killing 298.





In order to gain credibility, Van der Werff even obtained Dutch press credentials in 2019. Bonanza's main focus is on propaganda films they publish on YouTube. Their "magnum opus" was an "independent" MH17 documentary titled "MH17 - Call for Justice" premiered in Oct 2019.





The film was funded via Kickstarter, and they managed to reach their goal of 20,000 EUR with only 67 backers! One truth seeker donated a whopping 8,400 EUR, probably donating their life savings in their search for a better narrative.





A little bit about ourselves



Yana Yerlashova - Russian documentary filmmaker. Made 2 films on MH17, found important plane debris and made sure the Dutch Safety Board got them. The debris never made it to the final report. Thinks the official investigation is not done by the books and thus questionable. Has exclusive materials on the case that feed her doubts. Yana met Max while working on her first MH17 film. Since then they stayed in touch and now teamed up for a new MH17 investigation.

Max van der Werff - Independent Dutch researcher. His investigations led to the Dutch state conviction for torturing civilians in the Indonesian war for independence.


In the last 5 years spent more than 2.500 hours studying the MH17 air crash. Was interviewed by the Joint Investigation Team. Has strong doubts about the official version of events.

Since Malaysian airliner MH17 was shot down over Ukraine in 2014 - Max spent more than 2.500 hours studying the case. Went to the crash area twice and was interviewed by the Joint Investigation Team. He has strong doubts about the official version of events.

Yana met Max while working on her first MH17 film. Since then they stayed in touch and now teamed up for a new MH17 investigation.

And oh boy what they could achieve with this money — the dynamic duo traveled between Malaysia, Russia, Eastern Ukraine and the Netherlands, held press conferences and organized events, and of course produced a series of documentaries blaming Ukraine for the incident. The project raised just over \$23,000 in 18 days from 67 anonymous donors, with most of the funding coming – <u>according to Van der Werff and Yerlashova</u> – from Dutch donors. The Bonanza Media Twitter account even posted a jab at would-be Russian donors – complaining halfway through the campaign that <u>no Russian money had been pledged</u>.

Over the following year, Bonanza Media managed to put this modest budget (augmented, in the founders' own words, by personal financial contributions that made up 70% of the total budget) to a surprisingly elastic use: the team crisscrossed between Malaysia (including an interview with then Malaysian Prime Minister Mahathir Mohamad), Russia, Russian-occupied eastern Ukraine, and the Netherlands; produced a series of documentaries showcasing alleged witnesses of a Ukrainian fighter jet near MH17; hosted and attended several press conferences and events in the Netherlands, the U.K. and Malaysia; and commissioned a study from a Malaysian cybersecurity expert alleging manipulation of some of the audio intercepts used as evidence in the MH17 investigation.



But there's a darker, more cynical side to all this "independent journalism" — while producing their propaganda, Yerlashova was coordinating the project and its activities together with senior officers from the Russian intelligence agency GRU.

Evidence of Coordination with the GRU

No later than the summer of 2019, when Bonanza Media had completed its documentary and began showcasing it at public events, Yana Yerlashova was already coordinating the project's activity with senior officers from the GRU. Emails and phone records obtained by us indicate that by August 2019, Col. Sergey Chebanov – a graduate of Russia's Military Intelligence Academy with a roster of international diplomatic postings under his belt – was receiving regular updates about Bonanza's plans and upcoming events. During most of the phone calls with Yerlashova, cell-tower data shows, he was based at the GRU headquarters at <u>Khoroshevskoe Shosse 76B</u> in Moscow. For his clandestine communication with the Bonanza Media founder and CEO, he had bought a burner phone which he registered in the name of a non-existent elderly Georgian woman – standard trade-craft for GRU spies who did not want their calls to be traceable to them.

Yerlashova sent material related to their documentary and other Bonanza Media content to GRU Colonel Sergey Chebanov, often asking for comments and feedback. In one e-mail, she asked confirmation for a draft teaser for the public screening of Bonanza Media's documentary...

It appears from this exchange that GRU's Andrey Ilchenko had requested Anna Soroka – who seems to be his trusted political contact in the LNR – to arrange for the Bonanza Media team to be allowed to enter into and film in the separatist-controlled Donbas region. She replies that she needs clearance from both FSB and the Kremlin. As we have <u>reported earlier</u>, after an initial scuffle between the FSB and GRU for political and economic control over the two Russian-backed separatist territories in eastern Ukraine (LNR and DNR), by the end of 2014 the FSB had gotten the upper hand. This might explain the need for the GRU to use its remaining local "LNR" loyalists – of whom Anna Soroka appears to be a high-ranking one – for assistance in special GRU operations ("LNR" borders Russia and is a transit point into "DNR" where MH17 was shot down, and where the Bonanza Team presumably needed to travel to.)

This fact again disproves the Kremlin's lies that LNR & DPR were "independent states" that was so heavily promoted by several prominent vatniks. Anyway, the Bonanza team started their road trip to the puppet states in Jan 2020, naturally asking people for money on the way.

The documentary itself is classic propaganda — Yerlashova and Van der Werff travel around Eastern Ukraine, and interview people sympathetic to the Kremlin's cause. In addition, they challenge the official investigation conducted by the joint investigation team (JIT).

The documentary was shared by many Kremlin-controlled media outlets, including RT, but it failed to make a splash. Out of the 500 invites sent, only one journalist turned up to check if anyone else important went.







And soon after this, Bonanza Media decided to close down indefinitely — in Aug 2020, they announced that the group takes a "break" due to being unable to "break even". Yerlashova made one more "documentary" about the Odesa clashes in 2021, though:
