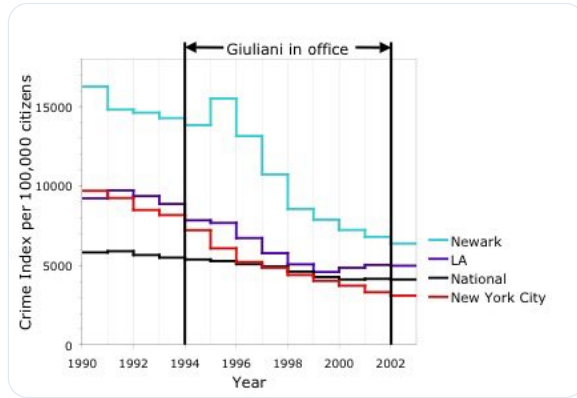

WASHINGTON -- Rudolph Giuliani's membership on an elite Iraq study panel came to an abrupt end last spring after he failed to show up for a single official meeting of the group, causing the panel's top Republican to give him a stark choice: either attend the meetings or quit, several sources said.

Giuliani left the Iraq Study Group last May after just two months, walking away from a chance to make up for his lack of foreign policy credentials on the top issue in the 2008 race, the Iraq war.

He cited "previous time commitments" in a letter explaining his decision to quit, and a look at his schedule suggests why -- the sessions at times conflicted with Giuliani's lucrative speaking tour that garnered him \$11.4 million in 14 months.

As New York mayor, Rudy Giuliani billed obscure city agencies for tens of thousands of dollars in security expenses amassed during the time when he was beginning an extramarital relationship with future wife Judith Nathan in the Hamptons, according to previously undisclosed government records.

The documents, obtained by Politico under New York's Freedom of Information Law, show that the mayoral costs had nothing to do with the functions of the little-known city offices that defrayed his tabs, including agencies responsible for regulating loft apartments, aiding the disabled and providing lawyers for indigent defendants.

Giuliani, Edwards quit White House race

SIMI VALLEY, California (Reuters) - Republican Rudy Giuliani and Democrat John Edwards abandoned their failing U.S. presidential bids on Wednesday, narrowing the race to two main candidates on each side before next week's nomination voting in more than 20 states.

Giuliani, the one-time front-runner who finished a distant third in Florida's Republican primary on Tuesday, traveled to California to endorse Arizona Sen. John McCain in a Republican battle against former Massachusetts Gov. Mitt Romney.

In a telephone interview, Mr. Giuliani acknowledged that a large segment of people who have worked with him over the last three decades have recoiled from Mr. Trump's candidacy. Among other things, his former aides have expressed concerns about Mr. Trump's questioning of the impartiality of a judge because of his Mexican heritage, and belittling the Muslim parents of a slain Army officer.

"They don't know him as well as I do," Mr. Giuliani said, adding, "There's not a racist bone in his body."

The real Donald Trump, he said, "is a guy without these prejudices."

Tapper pressed Giuliani on Trump's claim – in the video from a 2005 “Access Hollywood” interview published Friday by The Washington Post – that because he is a star, he could walk up to women and “grab them by the pussy,” asking who Trump did that to.

“First of all, I don't know that he did it to anyone. This is talk, and gosh almighty, he who hasn't sinned, throw the first stone here,” Giuliani said.

On Sunday, Mr. Trump's advisers sought to play down questions about the tax returns.

“The man's a genius,” Rudolph W. Giuliani, a former New York mayor and a close adviser to Mr. Trump, said on Sunday on CNN's “State of the Union.” “He knows how to operate the tax code for the people that he's serving.”

In this case, Mr. Giuliani added, Mr. Trump had simply acted as any responsible American businessman would to save money for his enterprises. Mr. Trump's investors, he added, could have brought legal action against Mr. Trump had he not taken advantage of the tax law's provisions to avoid taxation.

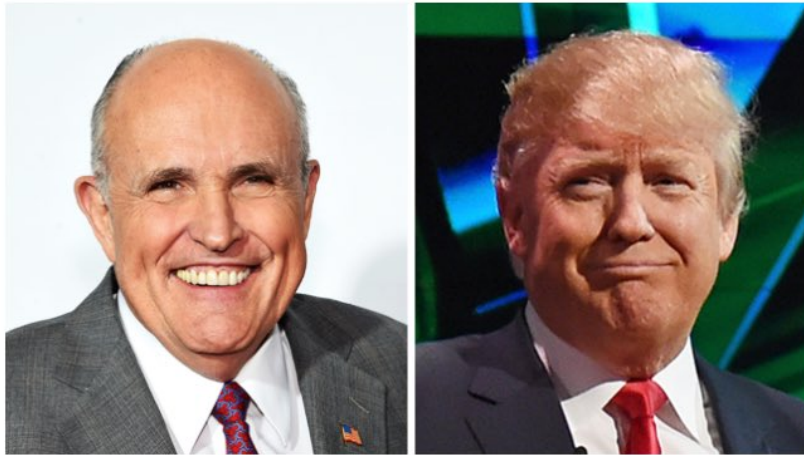

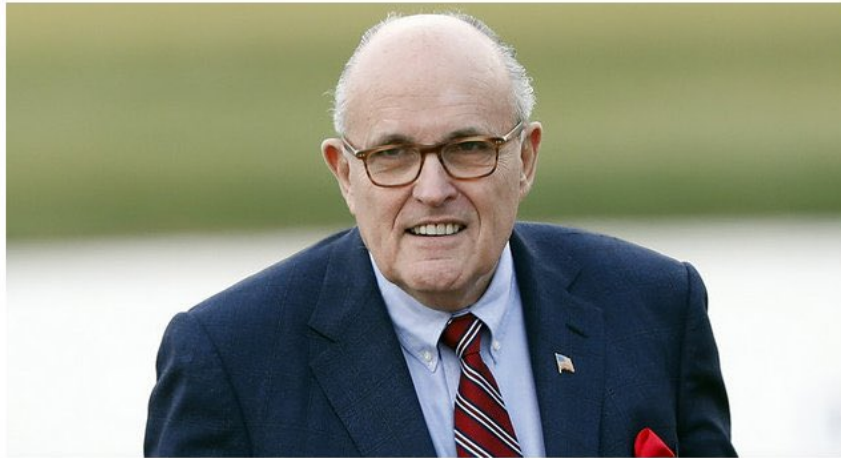

Treasury Sanctions Russia-Linked Election Interference Actors

September 10, 2020

Washington – Today, the Department of the Treasury’s Office of Foreign Assets Control (OFAC) designated four Russia-linked individuals for attempting to influence the U.S. electoral process. Russia uses a variety of proxies to attempt to sow discord between political parties and drive internal divisions to influence voters as part of Moscow’s broader efforts to undermine democratic countries and institutions. In the United States, Russia has used a wide range of influence methods and actors to target our electoral process, including targeting U.S. presidential candidates.

Treasury designated **Andrii Derkach (Derkach)** pursuant to Executive Order (E.O.) 13848 for his efforts to influence the 2020 U.S. presidential election. Derkach, a Member of the Ukrainian Parliament, has been an active Russian agent for over a decade, maintaining close connections with the Russian Intelligence Services. Derkach has directly or indirectly engaged in, sponsored, concealed, or otherwise been complicit in foreign interference in an attempt to undermine the upcoming 2020 U.S. presidential election. Today’s designation of Derkach is focused on exposing Russian malign influence campaigns and protecting our upcoming elections from foreign interference. This action is a clear signal to Moscow and its proxies that this activity will not be tolerated. The Administration is working across the U.S. Government, and with state, local, and private sector partners, to make the 2020 election secure.

“Andrii Derkach and other Russian agents employ manipulation and deceit to attempt to influence elections in the United States and elsewhere around the world,” said Secretary Steven T. Mnuchin. “The United States will continue to use all the tools at its disposal to counter these Russian disinformation campaigns and uphold the integrity of our election system.”

Derkach was Added to OFAC's List of Specially Designated Nationals in 2020 After Waging a Covert Influence Campaign to Undermine the 2020 U.S. Presidential Election

A seven-count indictment was unsealed today in federal court in Brooklyn charging Andrii Derkach, 55, of Ukraine, with conspiracy to violate the International Emergency Economic Powers Acts (IEEPA), bank fraud conspiracy, money laundering conspiracy, and four counts of money laundering in connection with the purchase and maintenance of two condominiums in Beverly Hills, California. Derkach allegedly concealed his interest in the transactions and violated sanctions imposed in 2020. Derkach remains at large. The charges and forfeiture action announced today include the first use of criminal and forfeiture powers targeting the concealment of ownership by senior foreign political officials, passed as part of the National Defense Authorization Act of 2021.



When Giuliani went to Ukraine in 2019 to try to dig up dirt on then-candidate Biden and his son Hunter Biden, Dubinsky was one of the people he met with. Giuliani has also met with Derkach, who was featured prominently in a conspiracy-tinged documentary released by the right-wing network OAN about the Biden family's dealings in Ukraine.

For his part, Kulyk wrote a dossier of disinformation about the Bidens, including claims about Hunter Biden's role on the board of Burisma, a major Ukrainian energy company. Kulyk also gave interviews to pro-Trump journalists and hired former Trump lawyers to help him spread his message to US officials during Trump's first impeachment.

Anti-Biden information operations

Taken together, these developments add to existing allegations that Trump's inner circle worked with accused Russian operatives to smear Biden, his 2020 opponent. The US and Ukrainian governments have now both said these three Ukrainian officials participated in the Kremlin's efforts to interfere with the 2020 US election.

The SBU on Monday released a video of testimony from Igor Kolesnikov, a former parliamentary aide who has been convicted of treason, saying that he managed a Russian intelligence operation overseen by the GRU (Russian military intelligence) that included Dubinsky and others aimed at undermining Ukraine's relations with its allies.

Other former prosecutors who worked with Giuliani raised the issue of him seemingly conducting American foreign policy in apparent violation of the Logan Act, which bars private citizens from negotiating with a foreign government on behalf of the U.S.

But no one has been convicted under the law, which dates back to 1799, and a potential case would likely be complicated by the fact that Giuliani was authorized by the president, the ex-prosecutors said.

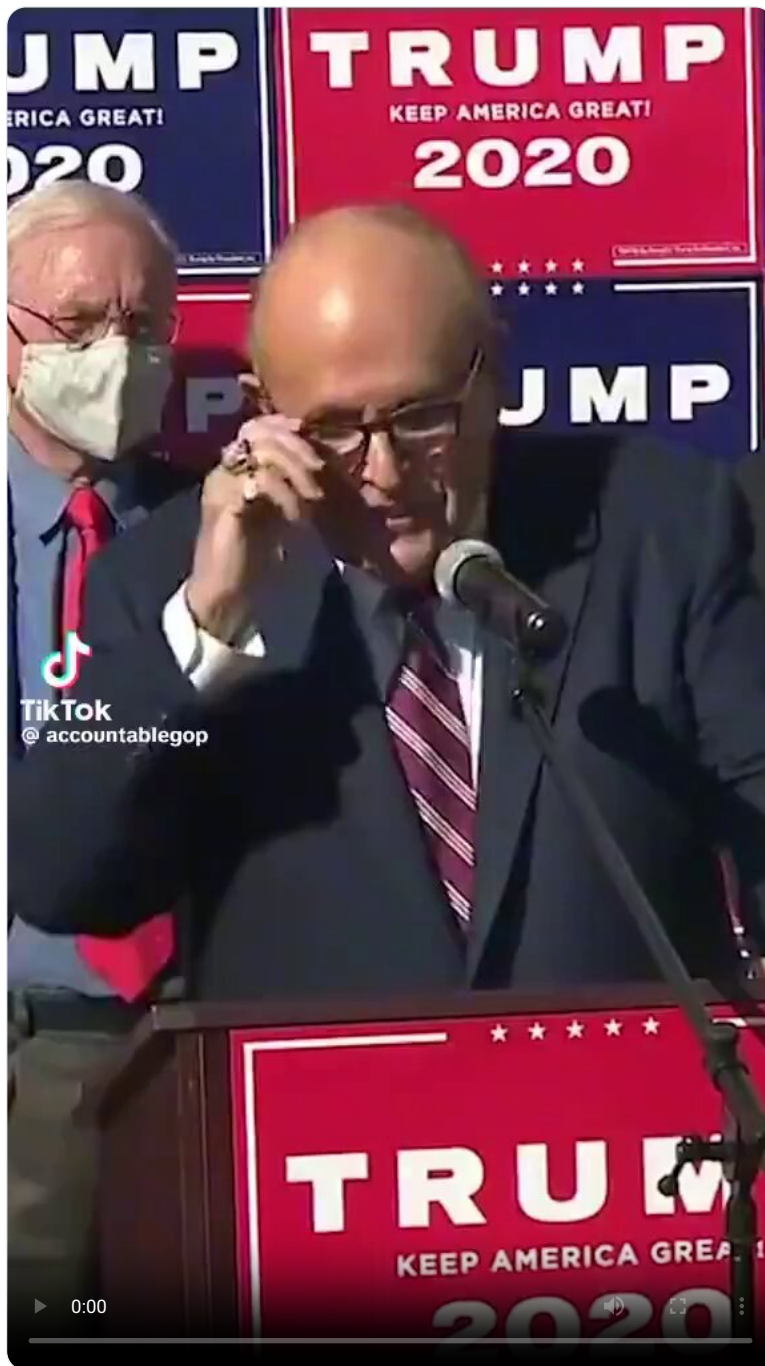
