U.S. ATTEMPT TO RESCUE IRAN HOSTAGES FAILS; 8 DIE AS PLANES COLLIDE DURING WITHDRAWAL

ACCIDENT ON GROUND
No Clashes Occur During Mission in Desert Area, White House Says

WASHINGTON, Friday, April 25 — The White House announced early this morning that the United States had attempted to rescue the American hostages in Tehran but that the effort failed and eight American crewmen died in Iran after the attempt was called off.

Giving only few details of the rescue attempt, the White House said that President Carter "has ordered the cancellation of an operation in Iran that was under way to prepare for a rescue of our hostages."

"The mission was terminated because of equipment failures," the White House said in a statement issued at 1 A.M.

"During the subsequent withdrawal, there was a collision between our aircraft in Iran," the statement said.

Many Questions Unanswered

It said that there were no hostilities, but that eight crewmen were killed and others were injured in the accident.

The White House said that the injured were successfully airlifted from Iran and were expected to recover.

The news came suddenly and raised many questions that White House spokesmen were unable to answer. They said that additional details would be provided later today.

It was the first known attempt by the United States to rescue the hostages, who have been in confinement since Nov. 4. The incident raised concern over the well-being of the hostages since the Islamic militants have threatened to kill the Americans if force was attempted to free them.

BANKS NEGOTIATING BIG LOAN TO OFFSET HUNT'S SILVER LOSS

Lenders Fear That Debt Problems Could Hurt Financial Markets Unless Help Is Provided

A group of major American banks concerned that the financial position of the Hunt brothers of Dallas remains precarious, is actively negotiating a large loan with the Hunts to offset the hundreds of millions the brothers lost in silver trading in recent weeks.

The bankers fear that without some financing, the Hunts may have difficulty in paying other debts, and that such problems could touch off further chaos in the financial markets.

Banking sources said yesterday, however, that no new loan had yet been made.

"There have been negotiations, but no terms have been finalized," a source at one large New York bank said.

The negotiations are taking place with the knowledge, and according to some reports with the acquiescence, of Paul A. Volcker, chairman of the Federal Reserve Board.

Volcker Denies Any Role

Mr. Volcker has come out strongly in recent months against providing credit for commodity speculation. In a statement issued yesterday, however, the Federal Reserve denied that Mr. Volcker had played any role in encouraging or approving of a loan to the Hunts, although the statement said that he had stayed in close touch with developments.

"Contrary to published reports, neither the Federal Reserve nor its chairman, Paul A. Volcker, initiated any effort to obtain bank loans in connection with financial transactions of the Hunt family," the statement said.

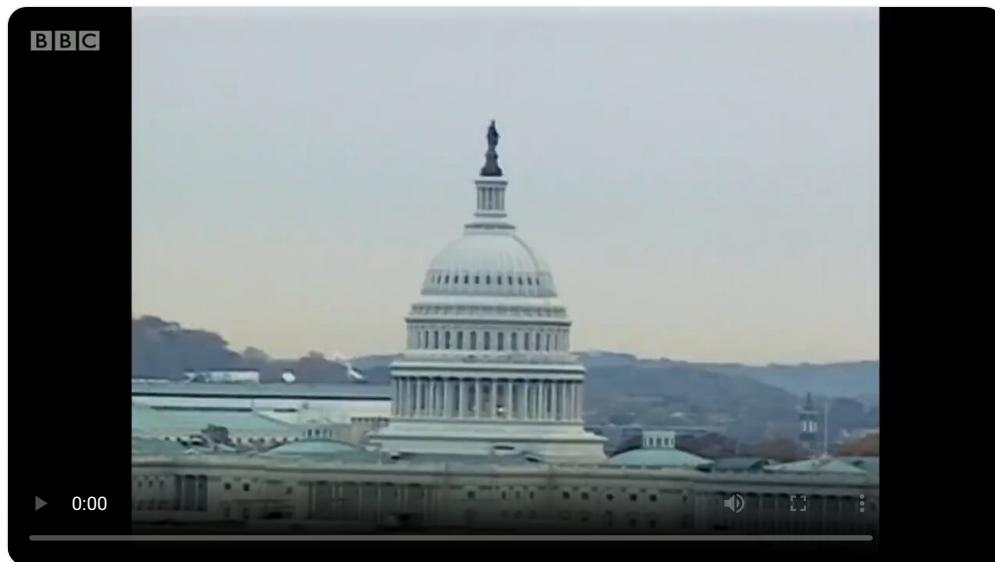

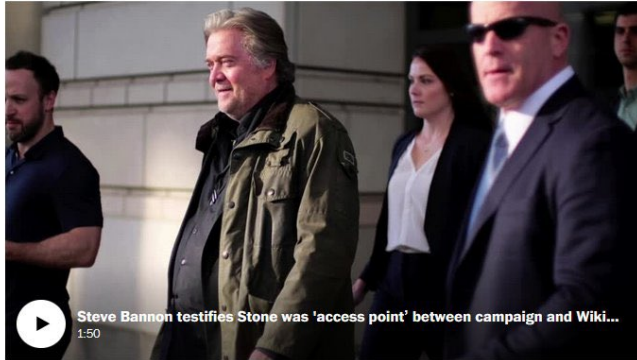

The committee is looking into what Bannon might know about any contacts during the campaign between Moscow and two advisers to the campaign, George Papadopoulos and Carter Page, they said.

William Burck, a lawyer for Bannon, told Reuters: "The Senate Intelligence Committee has expressed an interest in interviewing Mr. Bannon as a witness, just as they have many other people involved in the Trump Campaign. But the Committee has never suggested that he's under investigation himself and to claim otherwise is recklessly false."

Papadopoulos, a consultant, initially advised the presidential campaign of Republican hopeful Ben Carson before joining the Trump campaign. Page is also a consultant, who had business contacts in Russia.

On Sept. 7, Papadopoulos was sentenced to 14 days in prison. He had pleaded guilty last year to lying to FBI agents about the timing and significance of his contacts with Russians, including a professor who told him the Russians had "dirt" on Trump's Democratic presidential rival, Hillary Clinton.

No charges have been filed against Page.

Bannon, who has spent the year since his eviction from the White House supporting proto-fascist movements throughout Europe, neatly elucidated the importance of this alliance in a [2014 talk](#) at the Vatican. Traditionalists “believe that at least Putin is standing up for traditional institutions, and he’s trying to do it in a form of nationalism—and I think that people, particularly in certain countries, want to see the sovereignty for their country. They want to see nationalism for their country,” he explained during a question-and-answer session following his speech. “They don’t believe in this kind of pan-European Union, or they don’t believe in the centralized government in the United States. They’d rather see more of a states-based entity that the founders originally set up, where freedoms were controlled at the local level.”

The “Judeo-Christian West,” he concluded, “really have to look at what he’s talking about, as far as traditionalism goes—particularly the sense of where it supports the underpinnings of nationalism—and I happen to think that the individual sovereignty of a country is a good thing and a strong thing. I think strong countries and strong nationalist movements in countries make strong neighbors, and that is really the building blocks that built Western Europe and the United States, and I think it’s what can see us forward.”
